-We are asking our snowbirds when you return to please follow the CDC Guidelines to keep our park safe.

-It has been a rough few months with the Coronavirus. We have been fortunate in our park that no one has contracted the virus. Thank you to all who have been here all summer and have followed the guidelines to keeping us healthy. Our park really came through showing what a community means.

-When the virus started, we started feeding the sick and the shut-ins in our park, 3 days a week. We did this from May through part of June.

-We received many donations from residents and outsiders. We have also started a small food pantry so when residents are in need, we can make them meals. Thank you to all who donated food and helped to make this successful.

-We had a Memorial Day, a July 4<sup>th</sup> and a Labor Day Picnic. They were all well received. We set-up the clubhouse place settings six feet apart, and asked residents to wear masks when they weren't eating. We also had a lot of take-outs and deliveries. All functions were for residents only.

-The pool is open, allowing 6 people in the water at a time and 6 people on the deck at a time. **Residents only.** There are no alcoholic beverages allowed within the fenced in area around the pool. You may enjoy them behind the fence in the back of the pool. No beverages are allowed along the edge of pool, only on the tables under the over hang-per Pasco County. No coolers or containers are allowed.

-We had some of the roads and sidewalks repaired; fencing was replaced at the end of Birkdale Dr. and a new landing/stairs were installed at the office.

-We are having the canal construction work (on Empress Ln.) checked out by an engineer. We are asking our attorney to oversee this and find out why Pasco County is pumping all their storm water into our lake behind the clubhouse, from the Jarvis St. area east of Lanark Dr. and why our large lakes in the back are not draining down properly. We have sent registered letters to our Commissioners and Pasco County so this can be resolved.

-We have requested that there will not be spaghetti dinners or pancake breakfasts until further notice.
